a. <u>Warranty Terms:</u> 25 years, unlimited. To be based on single shift usage, 5 day workweek. Warranty coverage for multiple shift usage and/or over 40 hr. per week shifts will be pro-rated. **Exceptions:** Drawer units: 5 years. Hydraulic lift systems and controls: 5 years. Lighting products: 10 years.

Third party buy-out component warranties to be as per the manufacturer's document.

- c. Steel Carts & Racks (non-wire models) 5 years
- d. Wire shelving or other 'wire' products, Lab base cabinets, floor storage cabinets, wall cabinets, fume hoods and related fixtures and utilities including sinks, faucets, valves, electrical, etc. 1 year, or as per manufacturers' document. Single shift, original buyer only.

Product warranties are extended solely to the original buyer. Manufacturer's warranty applies to all products sold by JHA Techspace. Warranties state that products will be free from defects in materials and workmanship, when given normal, proper and intended usage, for the periods and under the terms noted. Warranties are extended by and are the responsibility exclusively of the manufacturers of products sold. Manufacturers agree to repair or replace at their option all defective products not performing substantially in accordance with applicable Product specifications, provided that buyer has given us written notice of such warranty claim within the warranty period.
